Limited Entry

Move-Ups, FEO (for entertainment only, no Qs toward titles), resets and Day-Of Entry allowed only if there is room.

Bitches in season will be allowed. They must wear properly fitted panties, will run at the end of each class, and must use a designated potty area.

Judges Briefing: 6:00pm

First dog on the line: 10 minutes after briefing.

Awards

Ribbons will be awarded for all qualifying runs and Rosettes will be awarded for titles earned at this trial.

For the Safety and Comfort of all!

- Maintain a buffer between all dogs when passing by.... The more distance the better
- All dogs must be always on leash unless they are in the ring. No Flexi/retractable type leashes or long lines to be used when walking dogs around the trial site.
- Dogs must be kept quiet and crated in vehicles between searches and potty breaks.
- Please keep voices quiet while talking in breezeway as voices are carried and can be quite distracting.
- Venues are hard to come by so PLEASE PICK UP AFTER YOUR DOGS! We would like to trial at the Facilities again. Few places are so dog friendly.

ABSOLUTELY NO DISCUSSING THE CURRENT SEARCH UNTIL ALL DOGS HAVE COMPLETED THEIR RUN.

How to Enter

Payment: E-transfer to sodaatreasurer@gmail.com (include note: "C-WAGS trial entries for [dog name]") upon confirmation of your entry.

Payment must be received within 48 hours of confirmation

Competitors, through submission of entry, acknowledge that they have read and understand the C-wags rules and regulations. Entries received after the trial is full will be added to the waitlist.

Disclaimer must accompany entry form or you will not be entered.

Complete one entry form per dog. Note: you may only enter one dog per round, but may enter multiple dogs per trial.

Entry Changes and Cancellations and Refund Policy

After league start any new entries will be accepted one week prior to start of next following league night providing available space. Changes and cancellations must be made in email to sodogactivities@gmail.com Cancellations must be made 5 days prior to the start of scheduled entry date. Refunds may only be issued upon written request for dogs or handlers withdrawing for medical reasons. Valid documentation for dogs must be provided by vet and for handlers a Doctors note. All decisions will be made on a case-by-case basis. No refund if a competitor is excused for any reason. If the trial must be cancelled, we will do our best to reschedule.

Disclaimer

I, the undersigned, have enrolled myself and my dog in dog training classes, workshops, seminars, evaluations, events, trials, or other related activities (Classes) offered by the South Okanagan Dog Activities Association (SODAA) club.

By signing hereunder, I certify that I have been informed and understand that there is always some unavoidable risk of injury involved when working with animals, especially animals with behavioural issues. I acknowledge that dogs can be inherently difficult to control and that not all dogs will be under control at all times resulting in the possibility of injury to myself, my dog, my family members, or third parties. Additionally, I have had full opportunity to discuss all concerns I have about the foregoing risks with SODAA and its authorized representatives. I have also made all inquiries and investigations to my satisfaction related to such risks, including, but not limited to, an examination of the training and evaluation area.

I hereby accept and assume, without reservation, all risks associated with my participation in the Classes, including, but not limited to: the risks of any and all injuries to myself, my dog and any of my family members or third parties who may attend; the risks that my dog may cause injury to other persons and/or dogs involved in the Classes; and the risks that saliva, water, food, snow and/or other debris may be present in the training area.

As lawful consideration for participating in the classes, I, for myself, my heirs, executors, administrators, legal representatives, successors and assigns (the "Releasing Party"), hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless SODAA, their directors, facilitators, and their members, managers, agents, and employees (the "Released Party") from any and all injuries, losses, claims and damages to any person or persons of any nature whatsoever, including claims arising from the Released Party's own negligence, and all costs associated therewith, including attorney's fees, court costs and consultant fees, arising from my participation in the Classes.

This Waiver of Liability & Informed Consent Release shall be legally binding on the Releasing Party. Should the Releasing Party assert a claim to the contrary to what I have agreed to in this Waiver of Liability and Informed Consent Release, the claiming party shall be liable for all expenses (including attorney's fees, court costs and consultant fees) incurred by both the Releasing Party and the Released Party.
